South Sound Chamber of Commerce Leg Coalition Bill Status & Upcoming Events Report - 2/18/18

We are now entering the 7th week of the Legislative session and Friday the 26th is the deadline for bills to be out of the opposite House committee for them to be considered "alive" for the remainder of session. Again, any bill that could be potentially be considered "necessary to implement the budget" is not considered dead at any time until sine die. So any bill still in a fiscal committee is still "alive" – sort of.

This past week we had the cut off for bills to be out of the House of Origin. Many bills did not make it through that process and you can see that our list has become much shorter.

On Thursday the Senate Ways and Means Committee held a hearing on SSB 6203 – the carbon tax bill. This bill implements a \$12/metric ton of carbon tax emissions with many exemptions for "Energy Intensive, Trade Exposed" industries. Some utilities testified "pro" on the bill because they believe it is better to move this through the Legislature rather than chance an initiative. Others business entities testified as "other" to reflect some of the positive changes that have been made, particularly the reduction in the amount of the tax. Many others remain "opposed" because there is no way for their industry to avoid the tax or the costs that will increase as a result of the tax. SSCCLC was signed in opposed because of the pressure this tax will put on fuel costs thus negatively impacting the gas tax money currently funding the Connecting Washington projects.

On Friday, the House Finance Committee held a hearing on the Capital Gains Tax proposal. Business after business got up and testified against this tax because of the negative impacts on selling businesses for retirement purposes (small business argument) and also because the tax would be considered an "income tax" and most likely would not pass Constitutional muster.

REVENUE IS UP AND BUDGETS WILL BE RELEASED DURING THE UPCOMING WEEK:

According to Chief Economist and Executive Director Steve Lerch, the General Fund-State (GF-S) revenue forecast has been increased by \$647 million for the 2017-19 budget cycle and by \$671 million for the 2019-21 budget cycle. The latest report reflects changes since the last revenue forecast on Nov. 20. The budget is expected to have \$3.8 billion in reserves at end of current biennia, before any supplemental budget is adopted (\$1.9 billion rainy day fund & \$1.9 billion unrestricted).

So now we are going to see the budgets released. The Senate Democrats are expected to release their budget tomorrow. House Democrats will release their budget on Tuesday, February 20th. Hearings in the Senate will start tomorrow afternoon and Hearings in the House will start Tuesday afternoon. We expect the budgets will include money for the last part of the McCleary fix which is about \$917 million. We also expect to see movement on SB 6614 and other bills like it that reduce the property tax levy utilized last year because of the additional revenue that has come in. However, there will still be pressure from some Democrats to enact some revenue enhancement to replace the property tax revenue loss if 6614 passes in order to ensure carry forward dollars. Republicans in both the House and Senate are not inclined to vote for any tax increase and we are not sure the votes are there in either of the Democratic caucuses for new or additional taxes either. The budget discussions should prove interesting.
